Abstract In this talk, a marginal-free measure of mutually complete dependence for discrete random vectors through subcopulas is defined, which generalizes the corresponding results for discrete random variables. Properties of the measure are studied and an estimator of the measure is introduced. Several examples are given for illustration of our results.
